



## **Backyard Contest Application**

November 4 and 5, 2011

At Clayton County International Park in Jonesboro, GA. I-75 at Exit 228 (Hwy 138) West 2 miles to the park on the left.

Barbecue is defined as meat and seafood, fresh or uncured, prepared on a wood or charcoal fire, based or not, as the cook sees fit, with any non-poisonous substances and sauces as the cook believes necessary. There are five categories in the contest: ribs, chicken, seafood, Brunswick stew, and sauce.

### **DEFINITION OF BACKYARD CONTEST CATEGORIES.**

#### **RIBS**

A pork rib entry is defined as the portion containing the ribs and further classified as a spare rib or loin rib portion. Country style ribs are not a valid entry.

#### **CHICKEN**

A chicken entry is defined as a fryer chicken or any portion of a fryer chicken cooked in pieces or whole.

#### **BRUNSWICK STEW**

A Brunswick stew entry is defined as any combination of meat and vegetables cooked together to form an edible concoction.

#### **BBQ SAUCE**

A BBQ Sauce entry is defined as any non-poisonous liquid prepared and used in the cooking process of the meat or used to enhance the flavor of the meat when served.

#### **ANYTHING BUT**

An "anything but" entry is defined as entering anything but pork and chicken samples. All entries must be prepared on-site but may be marinated or seasoned off-site.

### **BACKYARD CONTEST RULES**

Teams may cook with any type of wood and/or charcoal. Other flammables (propane, compressed or liquid gas, etc.) may be used within the cooker **ONLY** to **START** the **INITIAL** fire. No type of flammable may be used within the cooker once the meat has been placed there. Flammables may be used outside and away from the cooker to make

additional coals. Local fire and safety laws may prevent the use of any type of gas anywhere on the grounds at any time, and if so, these laws shall prevail.

Electrical devices may be used within the cooker as long as they do not directly generate heat. Approved devices include rotisseries, fans and delivery systems for approved fuels (e.g. Traeger grills). Electric smokers, holding ovens or any other devices with heat producing electric coils are not allowed.

Meat or seafood for the contest must be fresh. Meat or the “anything but” category may not be pre-cooked, sauced, spiced, injected, marinated, cured in any way, or otherwise pre-treated prior to official meat inspection. Brunswick stew and BBQ sauce maybe prepared off-site and warmed on-site before judging. All products entered in the contest must be maintained at a temperature below 40 degrees Fahrenheit prior to cooking, and at or above 140 degrees after cooking.

Judging (Saturday) time for the categories: Brunswick stew and BBQ sauce 9:00 A.M., “anything but” 10:00 A.M., chicken 11:00 A.M., ribs 12:00 noon. All judging will be blind.

Each contestant will be provided a 20’X 20 cooking area. This includes access to electricity and water. Teams should bring 150’ of electrical cord and a water hose. Additional space may be available upon request. Each contest must supply all of his own meat, cooking ingredients, individual cooking devices, utensils, and tables. All contestants MUST adhere to all electrical, fire, and other codes set forth in the acceptance package. Load-in will be from 9:00 A.M. to 4:00 P.M. on Friday, October 1, 2010. Thursday load-in will be available upon request.

Load-out will be allowed immediately following the announcement of winners scheduled for 7:00 P.M. Saturday, November 5, 2011.

No vehicle access to the cooking area will be allowed from 4:00 P.M. on Friday, November 4 until the end of the awards presentation on Saturday, November 5, 2011. Any contestant vehicle found in the cooking area after 4:00 P.M. will result in the team being disqualified. Entry fees will not be refunded.

## **OTHER CONTEST**

### **BEST PARTY (Friday)**

A group of local VIPs will visit each team at 9:00 P.M. on Friday to determine which teams are having the best party and/or the most fun. Judging criteria will be based on decorations, numbers of guests, food and fellowship. A trophy will be awarded for 1<sup>st</sup> place.
