Premier Sports Facility Management and Southern Crescent Tennis Association bring holiday cheer to children in need

There will be an opportunity for children under 10 years old to participate in the United States Tennis Association QuickStart Tennis program that uses short courts and modified equipment so children can experience the fun of tennis immediately.

Participation in Tennis for Tots is open to anyone who brings a new, unwrapped toy, game, or book with a retail value of at least \$10 to the Clayton County Tennis Center on December 10.
