Call to order

Coordinators are to start putting their uniform orders together so that the uniforms can be ordered and delivered in time for the upcoming season. Orders are due by the end of the week. Also, identify coaches for all teams planned for each park. Coaches for the even numbered age groups need to be identified first. Any new color schemes and mascots need to be identified by end of the week.
