Old Business

- Baseball/Softball Programming

New Business

- Youth Football Administrators Meeting Update – Koboi updated the staff on the meeting with the administrators over the parks that CCFL will be allowing into the league this coming fall. East Point, Forest Park, City of Riverdale & College Park are the possible additions to the CCFL. Clayton Football mandates for Coaches will be met by all incoming Coaches and teams. Koboi will set up a meeting between all administrators to go over all football rules and assure that rules are followed.
- Football Helmet Reconditioning – All helmets needing to be re-conditioned should be recognized and removed from inventory so that the helmets can be sent out for re-conditioning. Any helmet that has not been re-conditioned since 2013 should be set aside to be sent out. Helmets should be cleaned of all tape and decals before being sent out for re-conditioning. Koboi has created tags for all Parks and the bags with the helmets should have a tag attached to identify which park it needs to be returned to. Helmets should be ready to be picked up by Maintenance on Thursday morning. All ear-pads should be removed from the helmets.
- Clayton State University Athletics Meeting Update – Koboi was invited to sit in on the Clayton State Athletics meeting. Clayton State is proposing to be a partner with Clayton Athletics on several different levels with the recreational sports programs.
