Call to order

Old Business

- Youth Football
 - Team Certification (Roster Completions) – Coordinators turned in completed Team Books and will finish the books that are still outstanding. These books will be turned in to Koboi by Wednesday. Koboi will assist other members of SPYFL with finishing their books properly.
 - Jamboree Update – Teams were late and did not show up for their scheduled games. Safety concerns were raised for some areas. No one is allowed on the sidelines without proper credentials (this will be a NO TOLERANCE Issue). Issues of kids not playing were brought up around the league at different venues.
 - Regular Season:
 - Revised Schedules – Moving forward all games scheduled for Flat Shoals Park will move to Southern Crescent Stadium. Double Check with all teams to make sure that each team has the correct schedule. Attention should and will be placed on the details of facilitating the league and not on who wins.
 - Scorekeeping – Tammie received the scores for jamboree and Koboi will send the link to Dropbox to all Coordinators to place the scores each week so that the scores and standings can be kept up to date. Coordinators will open their park tab and enter the scores.
 - Flag Football
 - Schedules – The season will begin on September 12, all teams have been given the schedule.
 - Flags – Flags have been given to the Coordinators for each team.
 - Rules – Rules have been published for each team.
 - Coaching Credentials (ID Badges) – Any outstanding coaching credentials that need a picture should be sent to a Recreation Center for the picture to be taken.
